On page 4 it states “one original copy, three (3) identical paper copies, and one (1) electronic copy in pdf format” but on pages 22 and 35, it states “one (1) original, five (5) identical paper copies, and one (1) electronic copy.” Should we submit three copies or five copies?

On the first page it states that “separate bid submittals are required.” Does this mean that each of the four entities will need to receive their own original, set of copies, and electronic copy?
