# Preparing for Cold Weather

### Not your typical Florida weather.

Even the Sunshine State has freezing temperatures now and then. As uncommon as it may be, it is still important to be prepared for it, especially in Franklin County.

When the temperature dips below freezing for several hours it can cause widespread icing conditions throughout the county. With bridges being essential to transportation in Franklin County, we are especially susceptible to these icing conditions.

If travel is unavoidable, use extreme caution and ice can sometimes be impossible to spot. If your vehicle starts to slide, remain calm. Do not attempt to steer and do not slam on the brakes. Doing these things can take away what little control you have over your vehicle. Instead, gently press the brakes to slow your vehicle while allowing the wheels to still turn. This will bring your vehicle to a safe stop.

In past editions of this publication, we discussed the safety requirements surrounding generator and space heater safety. These are doubly important to bear in mind in these freezing conditions.

# Emergency Preparation for Elderly Citizens

Considering the special needs of elderly members of the community.

There are many people who require extra preparation and consideration when planning for a disaster. Among these people are elderly members of the community. Advanced age brings increased medical concerns, and increased reliance on medication and other medical needs, such as oxygen concentrators.

When preparing an emergency kit, ensure that extra supplies of medication are available. Bear in mind that in an area under a state declaration of emergency, you are able to get an emergency refill on medications even if you just had that prescription filled.

Also consider electricity dependency. If you are reliant upon a medical device that in turn is reliant upon electricity, it is probably best to evacuate ahead of a disaster. If you have nowhere to go, consider signing up for the Florida Special Needs registry. This is a confidential list of community members who have medical considerations that require extra attention than may be available at a typical storm shelter, and thus those on the Special Needs Registry are evacuated to a special shelter where that attention can be provided.

Cold weather brings its own unique set of dangers to be wary of.

- Use caution when crossing bridges. These can freeze before other areas, creating dangerous driving conditions.
- NEVER use a gas oven to heat your home. It produces carbon monoxide, which is a deadly gas that kills about 1,000 lives a year in America.
- Insulate exterior pipes. The water within can freeze causing the pipes to burst.
- Leave faucets running at a trickle at night. This makes it more difficult for the pipes to freeze.
