



# **Our Experienced Approach to the Project**

Roads Inc brings a team of professionals that have been working on Disaster contracts with Cities, Counties, State, and Federal agencies for over 25 years. We have the knowledge and proven experience to <u>guarantee</u> Franklin County full federal reimbursement for the services that Roads Inc will perform if awarded this contract.

Roads Inc. of NWF's entire disaster recovery, debris removal, and disposal process will be described in the following subsections, which illustrate the general sequence of disaster recovery and debris removal operations for known and predictable events, such as hurricanes, tornadoes, flooding, or similar events. This approach outlines the typical work flow between Roads Inc and Franklin County starting from contract award till FEMA reimbursement.

# Phase 1 – POST AWARD AND PRE-EVENT PLANNING

Upon contract award, Roads Inc will reach out to schedule a personal visit by the Roads Inc project manager. The purpose of the meeting is for a personal introduction of the key members of each party's team, discussion of the planning, training, and disaster response preparedness needs of the County. During this annual meeting we will determine the following key elements of the County's disaster preparedness:

- Identify and discuss proposed equipment storage areas.
- Identify and Pre-Authorize Temporary Disaster Debris Management Sites (DDMS).
- Identify local authorized landfills and final disposal sites.
- Review and Update contact information for emergency managers.
- Identify Debris Collection zone maps and primary road clearance routes.
- Outreach programs for utilizing local sub-contractors and vendors.
- Review and/or assist the County with preparing a State/FEMA approved Debris Management Plan.
- Discuss any recent State or Federal changes to the FEMA Public Assistance Program and Policy Guide (PAPPG).
- Discuss areas of concerns/issues the City encountered during the previous disaster and discuss preventative actions to ensure future success.



As hurricane season approaches, Roads Inc. conducts internal reviews of our systems, procedures, and inventory and perform maintenance on our equipment and relevant assets. We stock up on all necessary supplies and consumables, canvass our teaming partners, subcontractors, suppliers, reserve personnel, and continue to touch base with the County. We increase the frequency of our planning and operations meetings to ensure that all key management and support personnel are operationally synchronized for the upcoming season. We meet with our subcontractors and brief them on any relevant modifications to our response plans for the upcoming season.

#### Phase 2 - Alert

If a storm path is aimed at the vicinity of Franklin County, Roads Inc. of NWF personnel will begin to closely monitor the track and conditions of the storm. Roads Inc. of NWF is prepared for emergency response services 365 days a year, 24 hours a day. No less than 5 days before impending storm impact, Roads Inc. will make contact with the County to discuss the details of mobilizing and pre-positioning resources. Once a storm is within 96 hours of landfall, our team will conduct daily meeting (either in person or virtual) with the County daily teleconferences with the County and our team will occur to make any necessary resources adjustments that may be needed to made given the size of the anticipated storm event.

During this phase, we will put our management, supervisory, support, and reserve personnel, as well as our first response subcontractors and suppliers on a preliminary alert status. Our operations staff will review and satisfy our task preparation lists to ensure all necessary supplies, equipment, and assets are ready to go.

## Phase 3 – Mobilization

If the storm becomes a threat, 24-48 hours before impact, manpower and equipment are mobilized and staged in a safe location near the area of impact. Subcontractors are put on notice, and emergency communications are made available. Locations for a mobile command center are scouted and chosen based on factors such as proximity to major roads and severity of impact. Field maintenance/fuel personnel will prepare their assigned maintenance/fuel vehicles for deployment in accordance with the appropriate inventory and safety checklists.

Prior to landfall, equipment will be pre-staged at the closest mobilization point and contract administration headquarters. Additionally, our principal subcontractors will have equipment available in or near the County's location.

In this manner, Roads Inc. will have sufficient equipment to immediately start the initial cut and toss when weather permits and have sufficient equipment to begin the load and haul as soon as possible. Our equipment inventory is comprised of assets owned by Roads Inc and those readily available by our reliable sub-contractors. **Our 2024 Equipment Resources are listed below**:

# Phase 4 – Compliance Measures

Roads Inc. of NWF's Safety Officer will conduct a safety briefing and safety equipment check prior to equipment operation to ensure compliance with our Safety Plan. Within three days of Task Order/Notice to Proceed, Roads Inc. will furnish the County with a site-specific Management/Operations and Safety plan, along with a Quality Control Plan. All personnel records (management, supervisors, foremen and laborers) will be reviewed prior to deployment to ensure they have documentation of current training.

DMS teams will also secure all necessary clearances, collect pre-disposal soil samples, permits and licenses to operate the site(s) and will submit Site Plans to the County complete with Accident Prevention Plans, a Traffic Control Plan to properly manage sit ingress and egress, a Dust Control Plan, and/or a Fire Prevention Plan. Additionally, a complete Subcontracting Plan listing all subcontractors will be provided.

Within 48-72 hours, DMS locations will be fully operational, complete with ingress and egress points, inspection towers, water runoff protection and containment berms and/or geotextile.



Roads Inc. of NWF maintains the highest levels of safety, quality, and integrity in conducting our services and operations while adhering to all guidance set forth by OSHA.

# Phase 5 - Project Mobilization Team

Roads Inc.'s Project Mobilization Team of project managers and administrative staff will be on site within 12 hours of Task Order notification prior to or immediately following a disaster event. The Team will conduct a survey of the affected areas to ensure safe passage during the emergency road clearance phase and upcoming mission. Emphasis on safety during this phase is critical, as there may be downed electrical lines and other hazardous materials released.

After the assessment, staff will begin to stage and deploy equipment, crews and logistical support. Roads Inc. will establish the site locations in the disaster area for the temporary field offices, communication unit, lay-down yard and support systems, including a potential emergency base camp. The need for a mobile command field office will be evaluated based on the severity of the disaster. Evaluation surveys will be conducted by ground teams as well as by aerial survey using helicopters, if deemed necessary.

# Phase 6 - Mobilization-Emergency Debris Road Clearance (Cut & Toss)

This operation is accomplished when time is of the essence and should be completed within the first 72 hours after an event. Although this is a time critical operation, safety of personnel and the general public is paramount to a successful operation. Extreme caution must be exercised during this phase of the debris management operation to avoid downed live electrical wires and other such dangerous circumstances. Once this task is accomplished, or coinciding with the progress of this task, debris removal from public easements, property and rights-of-way begins. As tasked by the city, Roads Inc. will provide emergency road clearance which involves the emergency clearing, cutting, tossing and/or pushing of debris from the primary transportation routes to the medians or sides of the public rights-of-way (ROW).

Under direction of the County, Roads Inc. crews will work independently or in conjunction with the County crews to temporarily clear debris from pre-designated critical arteries to facilitate the movement of emergency vehicles and other critical traffic in the immediate aftermath of a disaster. Only a single lane is usually cleared at first with the additional lanes being cleared according to the needs and requirements of the affected community. In addition, entrances and routes to hospitals and emergency service facilities, such as fire and police departments, are given priority during this emergency debris and fallen tree clearance period.



The equipment utilized in this operation can include, but is not limited to: large rubber-tired loaders with grapples or rakes; small bobcat type loaders to access narrow areas; and other specialized clearing equipment as may be required by local conditions. Additionally, service trucks for maintenance and/or fuel and vehicles for personnel transportation and supervision are required. Personnel, such as heavy equipment operators, truck drivers, and operators with chainsaws, general laborers with tools, flagmen, mechanics, supervisors, and project managers are usually required.

# **Cut & Toss Operations**

- 1. Clear debris from roads in the order of and number of lanes as tasked by the County.
- 2. Clear debris from parking lots, areas of ingress and egress and any other area hospitals, shelters, emergency operations center, etc. as tasked by the County.
- Operators and hand crews will be instructed to perform in a workman-like manner to prevent damage to salvageable and/or undamaged property and prevent personal injury.
- 4. Attempt to make roadways and intersections as safe as possible from sight and traffic.
- 5. All supervisors will maintain accurate records of locations, date, time, personnel and equipment hours on Roads Inc's daily cut and toss report forms.

# Phase 7 – Hauling, Reducing, Tracking, Recording and Invoicing

Equipment certification areas will be established at select staging areas to undergo a thorough examination of the operability and safety of hauling vehicles and equipment. Once the vehicle is checked and approved, measurements of the truck beds will be taken to accurately determine the certified capacity of the hauling unit. Each hauling unit and piece of equipment with be assigned a unique ID number. This ID number is recorded on a FEMA-compliant certification form along with the certified capacity, driver's license number, driver's name and description of the equipment. The ID number from the FEMA-compliant certification becomes the official tracking identification for all loads that a particular vehicle hauls. The measured

capacity of all hauling vehicles is identified on the truck certification form and a placard affixed to each vehicle.



All crews will have daily reports that identify what equipment and personnel were in operation on a daily basis which also shows location of work performed. We will reconcile these reports on a daily basis by communicating with the County and their representatives. We will invoice



weekly, as needed, for the duration of this contract. All documents will be stored digitally and manually for 7 years for any audit needs. Roads Inc. maintains a very diligent protocol for field data collection, processing, and reporting. This is crucial to successful accounting, invoicing, and maximizing reimbursements

# **Debris Removal Operation**

In accordance with FEMA guidelines, the removal operations under this contract will be only for eligible debris meeting the criteria defined by FEMA as Category A. The image below, from the FEMA Public Assistance Program and Policy Guide (PAPPG) Version 4 2020, describes what type of debris removal can be eligible under Category A:

# I. Debris Removal (Category A)

Debris removal activities, such as clearance, removal, and disposal, are eligible as Category A if the removal is in the public interest based on whether the work:

- · Eliminates immediate threats to lives, public health, and safety;
- Eliminates immediate threats of significant damage to improved public or private property;
- Ensures economic recovery of the affected community to the benefit of the community at large;<sup>212</sup> or
- Mitigates risk to life and property by removing Substantially Damaged<sup>213</sup> structures and associated structures and appurtenances as needed to convert property acquired using HMGP funds to uses compatible with open space, recreation, or wetlands management practices. Such removal must be completed within 2 years of the declaration date unless extended by the FEMA Assistant Administrator of the Recovery Directorate.<sup>214</sup>

Debris includes, but is not limited to, vegetative debris, construction and demolition debris, sand, mud, silt, gravel, rocks, boulders, white goods, and vehicle and vessel wreckage.

For a PNP, eligible debris removal is limited to that associated with an eligible facility, including debris on the property of the eligible facility.

All eligible debris will be picked up and loaded into haul trucks in a safe and workman-like manner to and transported to the DMS sites for processing for final disposal. Safety will not be compromised. All crew foreman and field supervisors will be responsible to ensure a rapid and cost effective as possible operation. In accordance with FEMA guidelines, Hand loading is not permitted.

All vegetative debris and construction and demolition (C&D) materials will be collected and hauled using heavy equipment to ensure maximum loading and safe transport of materials within EPA and DOT standards. Tracked



equipment is prohibited on roadways and all hauling units are mechanically loaded and capable



of dumping or unloading their own loads. Roads Inc of NWF implements a clean as you go policy to make sure no debris piles similar in material are skipped over.

Traffic control personnel, with appropriate traffic control safety equipment, will be stationed at each approach point of the work area to maintain traffic control and to prevent personal injury. Additional traffic control personnel will be stationed throughout the area, as needed, to ensure safe operations.

#### **Continued Quality Assurance**

To ensure we meet the recovery needs and expectations of Franklin County, daily progress meetings between Roads Inc and the County representatives will be held throughout the removal operations process. These meetings will allow Roads Inc's Operation managers to assist in resolving any issues in a real time effort, provide status updates to sector maps, as well as identify and resolve any damage reports.

#### Separation of Debris

Every effort will be made to separate debris on the right-of way before loading. In the event debris materials still become mixed. These loads are classified as mixed debris loads and will be directed to the "mixed debris" pile at the DMS. This material will be sorted and separated by machines with grapples and thumbs and by hand labor and placed into the C & D, Vegetative, HHW, White Goods, and Metals piles.

# Hazardous Trees, Limbs, and Stump Removal

Roads Inc tree trimming crews will be deployed as needed to address hazardous trees and limbs that are identified by Franklin County representatives as a risk to public safety. Under FEMA guidelines, a hazardous tree is defined as a tree that is 6 inches or greater in diameter, and leaning at an angle greater than 30%, or has more than 50% of its crown damaged, that presents a threat or danger to the general public. A hazardous limb is a limb or branch that is greater than 2 inches in diameter, broken or partially broken, and is in danger of falling. Hazardous identified by Franklin County representative will be removed and hauled to the DMS by the hazardous stump crews. Trees, limbs, and small stumps will be cut down and placed on the ROW for collection and transport by debris removal crews to the DMS for reduction.



# **Operational Sequence of Removal**

#### First Pass

During the first pass, crews will cut and load storm debris that has typically fallen in the rights-of-way including debris from the initial road clearing activities. Additional tasks, such as hazardous tree removal, hazardous stump removal, and other similar scopes of work would also be implemented. At the end of the first pass of debris removal, this allows time a space for residents to bring additional eligible storm debris to the curbside. Our Crews begin ramping up to start the second pass.

# Second Pass

During the second pass removal operations and reduction will have been in full force and making great progress. Towards the end of the second pass hot spot crews would continue to cleanup any debris that has time or safety constraints. The vast majority of storm debris would be cleaned from the rights-of-way, and the Roads Inc Project Manager will begin focusing on project completion procedures. \*(Depending on the severity of the debris, multiple passes may be needed to allow residents time to bring eligible debris to the right-of-way.)

# \* Final Pass

During the final pass, crews will systematically remove the last piles of debris. We will provide the County with an updated map or road list of "final pass" areas at the end of each day. At the end of the final pass, debris removal operations will be 100% complete and the Project manager will start on the DMS site reclamation process.

# **Debris Management Site (DMS)**

Roads Inc. shall provide all specified equipment, operators, and laborers for DMS management and debris reduction operations. Within 24 hours of Task Order Notice to Proceed, personnel and equipment will be deployed to the Debris Management Site (DMS) locations identified and permitted through our pre-event approval process. The operation may include, but is not limited to the building of roads, erecting of fences, construction of containment areas, and placement of inspection towers suitable to the FEMA requirements.




Depending on the size on location of the DMS, the equipment and crew operating the site may consist of:

- 1-2 Excavators
- 1-2 D6 Dozers
- 1-2 all-terrain towers
- 1 water truck
- 1 motor grader
- 1-2 tub grinders or Air Curtains
- one site manager
- one night manager if necessary
- 2-4 light plants



The inspection of every load, in and out, is critical to the documentation of the overall process. The DMS inspection towers provide a location for load verification and documentation programs of all incoming and outgoing debris. Once documented, all debris is processed in accordance with applicable FEMA, local, state and federal rules, standards, and regulations.

- Maintenance/Fuel Vehicles and Personnel Maintenance/fuel vehicles will be assigned and manned as needed to provide an adequate supply of fuel to maintain equipment operations. Maintenance/fuel vehicles will be assigned and manned to provide all required field maintenance.
- Staging The following information will be used to create a location specific site management and safety plan:





<u>Site Access</u> - Separate points of ingress and egress should be established if possible. Temporary acceleration and deceleration lanes should be established adjacent to the primary road leading to and from site access points, approved by the County. All temporary roads leading to and through the debris-staging site should be constructed and maintained for all weather use.

<u>Inspection Towers</u> - Inspection towers shall be constructed to facilitate observation and quantification of debris hauled for storage at debris staging sites. No less than two inspections towers should be utilized at each debris staging site. One tower at point of ingress for use by company inspector and/or Government inspector, one tower at the point of egress to ensure all debris hauling trucks are in fact empty upon leaving the site, one tower may be utilized if ingress and egress point is the same. The egress tower shall be manned by at least a representative of Roads Inc. of NWF.

<u>Traffic Controls</u> - Traffic control personnel, with appropriate traffic control safety equipment, will be stationed at the ingress observation tower to maintain vehicular and pedestrian traffic control. Additional traffic control personnel will be stationed throughout the site, as needed, to enforce proper dumping and prevent personal injury to ensure compliance with the Accident Prevention Plan as part of our Safety Plan.

<u>Clearing And Grading</u> - Clearing and grading of debris staging sites will be accomplished, to the level required, in accordance with the site management plan and task order Franklin County.

<u>Environmental Protection</u> – Roads Inc. of NWF will work diligently with FDEP, DEP, and the Army Corps. of Engineers to ensure compliance with required standards (Clean Water Act, Storm Water Act, Resource Conservation and Recovery Act, Superfund Amendments, Reauthorization Act and others).

# **DMS Remediation**

The scope of remediation is determined during operation and closure, by terms of the land lease (if any), government directive or task order. Remediation consists of final removal of all debris (including residual debris), removal and remediation of HTW, abatement of any safety and/or environmental concerns (to include environmental testing and/or monitoring, if required), the removal of temporary structures (including any inspection towers), grading and leveling, removal of roads and fencing, if appropriate, and potentially grassing or seeding of the site, if required, to documented pre-use condition.

Closure Procedures - Pre-use inspection and documentation information shall be utilized as a guide to restore each site to pre-use condition. If contaminants are identified in post use test results that were not present in pre-use test results, remediation of the site or area will



be accomplished in accordance with Federal, State and local regulations, as well as current industry standards.

- Removal Of Temporary Structures All temporary structures such as fencing, inspection towers, temporary offices, sanitary facilities, etc., shall be removed from each site.
- Landscape Operations Each site shall be graded, as required to return the topography to pre-use elevations, unless otherwise directed by the property owner. Each site will be restored to pre-use condition by seeding, fertilizing and laying of straw as well as replacement of agreed-upon shrubs and/or trees.
- Final Inspection, Released and Acceptance of Government and/or Landowner Roads Inc. of NWF representatives, the Supervisor responsible for a particular site, the Owner's Representative and if applicable, the landowner shall constitute an inspection team. Roads Inc. of NWF's supervisor responsible for the applicable site shall have, for examination by all Inspection Team members, the documentation package to include pre-use and closure inspection documentation as well as all chronological documentation created during the operational period. After all inspection team members accept the post closure condition of each site, a release and hold-harmless for Roads Inc. of NWF shall be signed by Franklin County and/or landowner, releasing Roads Inc. of NWF of any further responsibility and liability.

# Phase 8 - Project Closeout

A final report will be submitted to the County upon project closeout. Roads Inc will prepare and submit a detailed description of all debris management activities including total volume of debris by type, final disposal locations and amounts of debris delivered to each, and total cost of the project invoiced to the County. Roads Inc will also supply additional information upon requested by the County.

Roads Inc is trained and experienced in providing the necessary documentation and assistance toward the preparation of reimbursement claim worksheets for the County. If requested, Roads Inc will provide the County with turnkey services or guidance and technical assistance to ensure proper preparation and submittal of claims for reimbursement and other available funding. Roads Inc's careful attention to documentation and strict quality control procedures will aid in the acceptance of a claim for reimbursement.



# Subcontracting

#### **Subcontracting Plan**

Roads Inc. of NWF maintains a large network of pre-screened and fully qualified subcontractors, including local and preferred vendors. Roads Inc's subcontractors are evaluated extensively, including past performance, equipment and personnel availability, mobilization timeframes, insurance, and cost.

The use of local resources is vitally important to a successful disaster recovery operation. Roads Inc proudly promotes community involvement by working closely with local suppliers and vendors when the situation allows. We utilize local vendors to the maximum extent possible to minimize load times, transportation costs, and schedule risk.



Because of its importance, we have developed a vast network of subcontractors that are uniquely qualified and meet all operational requirements envisioned under this solicitation.

Roads Inc. has access to more than 100 firms through our prequalified supplier database which includes Small Business Firms. This database facilitates our ability to identify firms qualified for specific scopes of work and allows Roads Inc. to efficiently sort the firms by type of service and size of business.

Throughout its history, Roads Inc. of NWF has maintained strong relationships with local vendors and subcontractors. We pride ourselves

on facilitating local involvement during recovery efforts and encourage local knowledge and experience. Roads, Inc. has assembled a cadre of subcontractors which includes SBE, MBE, WBE, and VOSB (including Service-Disabled VOSB) contractors. We actively recruit new subcontractors to work with even during the recovery process and as new projects are awarded.

**Roads Inc. of NWF may Sub-contract up to 30-60% of work to be performed under this contract, depending on the strength of the storm.** As a potential leader in the recovery industry, Roads Inc. has developed an inherent understanding of how to direct emergency response and recovery. Roads Inc. has a large network of subcontractors and maintains long standing relationships with key subcontractors who ensure our ability to maintain full

Additionally, at the discretion of the contracting agency, all subcontractors will be approved prior to beginning work. 

To whom it may concern:

On October 10, 2018, Hurricane Michael made landfall in the Panhandle of Florida near Tyndall Alrforce Base as a Category 5 Hurricane, with maximum wind speeds of 140 knots (161 mph) and a minimum central pressure of 919 millibars (mb).

Thirteen (13) of sixteen (16) counties under the jurisdiction of the Florida Department of Transportation (FDOT) – District Three Office was severely impacted by the storm. Not only did the Department incur damage to its infrastructure but the State Roads and their Rights-of-Way (ROW) were littered with damaged/entangled/down trees, powerlines and construction and demolition debris.

The Department divided the impacted areas into three (3) regions based off initial forecast of vegetative debris within the ROW. In addition to debris removal on the State Road system, the Department was assigned to assist several fiscally constrained counties within the Impacted areas with their debris removal operations. The Department advertised four (4) debris removal contracts, three (3) for On-System roadways and one (1) for Off-System roadways in Calhoun County. Roads, Inc., was the successful bidder on two of these contracts.

The Department entered into contract H3-515 with Roads, Inc. to perform Emergency Debris and Hazardous Tree, Limb and Stump Removal services along the rights-of way of the state roads in Walton, Holmes, Washington and Jackson counties. Under this contract Roads, Inc. removed in excess of 2,000,000.00 CY of vegetative debris from the Departments ROW's. This quantity does not include hazardous limbs, hazardous trees, stumps or construction and demolition debris. Monitored/documented debris was transported to a Florida Department of Environmental Permitting (FDEP) Debris Management Site (DMS), established by Roads, to be reduced and hauled to its permitted final disposal site in accordance with contract documents. After removal of all reduced debris, the DMS sites were restored in accordance with FDEP requirements. Debris removal services were completed within the time frame, established by the Department, from October 19, 2018 until May 31, 2019.

The Department also entered into contract H3-519 with Roads, Inc. to perform Emergency Debris and Hazardous Tree, Limb and Stump Removal services along the rights-of way of off-system roads with Calhoun County. Under this contract Roads, Inc. removed in excess of 2,000,000.00 CY of vegetative debris from the county ROW's. This quantity does not include hazardous limbs, hazardous trees, stumps or construction and demolition debris. Monitored/documented debris was transported to a Florida Department of Environmental Permitting (FDEP) Debris Management Site (DMS), established by Roads, to be reduced and hauled to its permitted final disposal site in accordance with contract documents. After removal of all reduced debris, the DMS sites were restored in accordance with FDEP requirements. Debris removal services were also completed within the time frame established by the Department, from October 19, 2018 until May 31, 2019.

Total cost associated with debris removal services for both contracts was in excess of \$50,000.000.00.

Roads, Inc. worked closely with Department Staff and the FDOT Monitoring Team to perform debris removal services in a manner to maximize reimbursement in accordance with FEMA guidelines.

In September, 2020 our area was hit by Hurricane Sally. It was the worst natural disaster in Escambia County, FL since Hurricane Ivan in 2004. As the current FDOT maintenance contractor for the State Roads in Escambia County, Ferrovial was tasked with clearing these roads and hauling off the debris for emergency services. Ferrovial contacted Roads Inc for performing this debris removal and within 24 hrs, Roads Inc deployed over 40 crews onto the State Road system. These highly efficient crews consisted of self-loaders, dump trucks, bucket trucks, loaders, excavators, chainsaws, arborists, certified flagmen, DOT trained MOT crews, and several supervisors.

Throughout the entire project they were very responsive and pleasant to work with. They truly revealed a commitment and desire to provide help during such times of crisis. They managed the project very well and worked closely with me to ensure our priorities were taken care of. I was also pleased with the level of detail to record keeping and documentation, as that is an important component for FEMA reimbursement requests.

In the end, Roads Inc of NWF removed and hauled all vegetative debris hazards off approximately 855 lane miles on the State Road system. They quickly completed this work in a swift 6 days. The final dollar value of this contract was approximately \$982,000.

In October, 2018 Northwest Florida was hit by Hurricane Michael a Category 5 storm. It was the first Category 5 hurricane on record to impact the Florida Panhandle. The FDOT had pre-event cut and toss contract in place with Roads Inc of NWF and a pre-event monitoring contract with Metric Engineering. As an experienced monitoring firm for several DOT agencies, we have worked with disaster contractors across the country. Roads Inc has proven to be an experienced disaster response team and have regularly exceeded the owner's/state's expectations.

Roads Inc's contract required them to pre-stage cut and toss crews 48 hours prior to the storm and then deploying the crews immediately after the storm passed. During the 18 months that followed Hurricanes Ivan (Sept 04) and Dennis (July 05), I acted as a coordinator for the local government, the Santa Rosa Island Authority. In that role, our office monitored the daily work, prioritized and measured the effort, and reviewed pay requests. Over 500,000 cubic yards of sand was screened on Pensacola Beach to remove storm debris.

Roads, Inc. was one of two local contractors selected to perform the storm recover work on the beach. They were mobilized within days after the request was issued. 

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

An individual who is a U.S. citizen or U.S. resident alien;

 A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;

. An estate (other than a foreign estate); or

A domestic trust (as defined in Regulations section 301.7701-7).

Establishing U.S. status for purposes of chapter 3 and chapter 4 withholding. Payments made to foreign persons, including certain distributions, allocations of income, or transfers of sales proceeds, may be subject to withholding under chapter 3 or chapter 4 of the Code (sections 1441–1474). Under those rules, if a Form W-9 or other certification of non-foreign status has not been received, a withholding agent, transferee, or partnership (payor) generally applies presumption rules that may require the payor to withhold applicable tax from the recipient, owner, transferor, or partner (payee). See Pub. 615, Withholding of Tax on Nonresident Aliens and Foreign Entities.

The following persons must provide Form W-9 to the payor for purposes of establishing its non-foreign status.

 In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the disregarded entity.

 In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the grantor trust.

 In the case of a U.S. trust (other than a grantor trust), the U.S. trust and not the beneficiaries of the trust.

See Pub. 515 for more information on providing a Form W-9 or a certification of non-foreign status to avoid withholding.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person (under Regulations section 1.1441-1(b)(2)(iv) or other applicable section for chapter 3 or 4 purposes), do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515). If you are a qualified foreign pension fund under Regulations section 1.897(I)-1(d), or a partnership that is wholly owned by qualified foreign pension funds, that is treated as a non-foreign person for purposes of section 1445 withholding, do not use Form W-9. Instead, use Form W-8EXP (or other certification of non-foreign status).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a saving clause. Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

 The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.

2. The treaty article addressing the income.

The article number (or location) in the tax treaty that contains the saving clause and its exceptions.

The type and amount of income that qualifies for the exemption from tax.

Sufficient facts to justify the exemption from tax under the terms of the treaty article.

**Example.** Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if their stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first Protocol) and is relying on this exception to claim an exemption from tax on their scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

#### Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include, but are not limited to, interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third-party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

1. You do not furnish your TIN to the requester;

 You do not certify your TIN when required (see the instructions for Part II for details);

3. The IRS tells the requester that you furnished an incorrect TIN;

 The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only); or

 You do not certify to the requester that you are not subject to backup withholding, as described in item 4 under "By signing the filledout form" above (for reportable interest and dividend accounts opened after 1983 only).

#### What Is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all U.S. account holders that are specified U.S. persons. Certain payees are exempt from FATCA reporting. See *Exemption from FATCA reporting code*, later, and the Instructions for the Requester of Form W-9 for more information.

## Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you are no longer tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account, for example, if the grantor of a grantor trust clies.

#### Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

## Specific Instructions

#### Line 1

You must enter one of the following on this line; do not leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9.  Partnership, C corporation, S corporation, or LLC, other than a disregarded entity. Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2.

 Other entities, Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. Enter any business, trade, or DBA name on line 2.

• Disregarded entity. In general, a business entity that has a single owner, including an LLC, and is not a corporation, is disregarded as an entity separate from its owner (a disregarded entity). See Regulations section 301.7701-2(c)(2). A disregarded entity should check the appropriate box for the tax classification of its owner. Enter the owner's name on line 1. The name of the owner entered on line 1 should never be a disregarded entity. The name on line 1 should be the name shown on the income tax return on which the income should be reported. For example, if a foreign LLC that is treated as a disregarded entity for U.S. federal tax purposes has a single owner that is a U.S. person, the U.S. owner's name is required to be provided on line 1. 
